WHEREAS, the City Council of the City of Watson has adopted Ordinance No. 7-13-2010-3 an ordinance amending Chapter Four of the City's code regarding utilities and the water system (the "Ordinance");

WHEREAS, Minnesota Statutes, section 412.191, subdivision 4 allows publication by title and summary in the case of lengthy ordinances or those containing charts or maps;

WHEREAS, the City Council determines the following summary clearly informs the public of the intent and effect of the Ordinance.

NOW, THEREFORE, BE IT RESOLVED, the City Council hereby approves the following summary language to be published in lieu of publishing the entire Ordinance:

**City of Watson An Ordinance Amending Chapter Four of the Watson City Code Regarding Utilities and the Water System**

The City Council of the City of Watson has adopted Ordinance No. 7-13-2010-3 amending Chapter Four of the Watson City Code Regarding Utilities and the Water System. The amendments include, but are not limited to, requiring connection to the city's utilities, voluntary discontinuation of service, allowing city access to property to read or repair meters as needed, prohibiting running water to other properties, prohibiting clear water discharges and establishing a surcharge for such connections, connections to sanitary sewer system and related excavations, procedures, and fees, and requiring compliance. The full text of the ordinance is available for inspection at the Watson City Hall and the City's usual posting places.

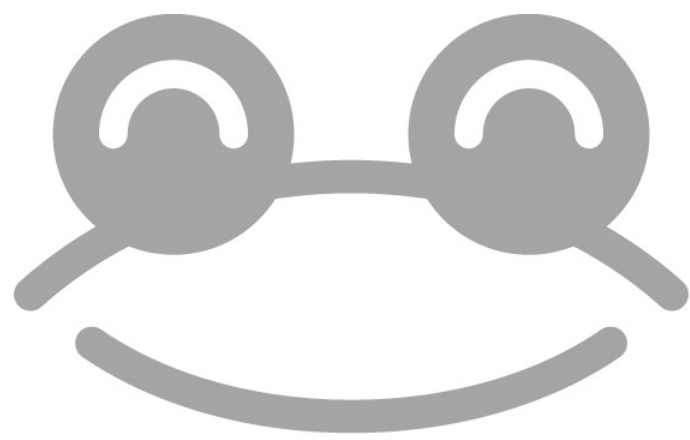
